Resolution # 132 <u>Regarding Fiscal Year 2020-2024 Capital Plan Funding for School Accessibility Projects</u>

Whereas, the Americans with Disabilities Act (ADA) became federal law in 1990; and

Whereas, the ADA states: "No qualified individual with a disability shall, on the basis of disability, be excluded from participation in or be denied the benefits of the services, programs, or activities of a public entity, or be subjected to discrimination by any public entity;" and

Whereas, in December 2015, following an investigation of New York City Department of Education (DOE) elementary schools, the United States Department of Justice (DOJ) found that the DOE was not compliant with the ADA, had an "abysmally low percentage" of accessible elementary schools, and needed to develop a "system-wide remediation plan to address the lack of accessibility;" and

Whereas, the DOE has approximately 1,800 schools in 1,300 buildings in 32 geographic districts; and

Whereas, 28 years since the passage of the ADA and three years since the DOJ findings, DOE data show that only one out of every five city schools is fully accessible to students, parents, staff, and other community members with physical disabilities; and

Whereas, students with physical disabilities find themselves cut off from the majority of DOE schools because of architectural barriers and are, instead, forced to travel significant distances and make academic and curricular compromises to attend schools they can physically access; and

Whereas, the accessibility varies dramatically by district with District 2 having more than 25 accessible buildings and District 16 having no accessible buildings as of July 2018; and

Whereas, only 31% of schools in Community School District 30 are fully accessible; and

Whereas, the Fiscal Year 2015-2019 DOE Capital Plan included only \$100 million to improve school accessibility, reflecting less than one percent of the total funding in the DOE Capital Plan; and

Whereas, in the city budget adopted in June 2018, Mayor de Blasio and the City Council added \$150 million over three years for school accessibility, recognizing the need to increase the accessibility of New York City public schools; and

Whereas, this funding will provide \$50 million per year for Fiscal Years 2019, 2020, and 2021; and

Whereas, it is estimated that the City will need an additional \$750 million (for a total of \$850 million) over the Never doubt that a small group of committed citizens can change the world. Indeed it is the only thing that ever has. ~ Margaret Mead next five-year period to bring a minimum of one-third of schools in each district of the City to full accessibility; and

Whereas, the City's goals for inclusion and diversity must include providing students with physical disabilities the same opportunities as their nondisabled peers and creating a school system where all are welcomed and included;

Therefore, Be It Resolved, that Community District Education Council 30 calls upon the New York City Department of Education to include \$850 million in the 2020-2024 Capital Plan to fund accessibility projects with the goal of making at least one-third of New York City public schools in each district accessible.

RESOLUTION #133

RE-ZONING JACKSON HEIGHTS AND ZONING NEW SCHOOL 398

Whereas, the NYC Department of Education has constructed a new building, Q398, located at 69-01 34TH Avenue in Jackson Heights which will serve as an Elementary School serving approximately 476 students; and

Whereas, District 30 schools in Jackson Heights have historically been over utilized; and

Whereas, Community District Education Council 30 (subsequently referred to as "CDEC30") has reached out to the impacted communities by means of meetings, electronic and social media; and

Whereas, CDEC30 has worked collaboratively with the NYC Department of Education Office of District Planning in an effort to accommodate the needs of the involved school communities; and

Whereas, CDEC30 believes that the plan now submitted by Dr. Philip A. Composto, District 30 Community Superintendent, represents the best available compromise between all parties; and

Whereas, CDEC30, in collaboration with the DOE, will monitor the implementation of this plan and its impact upon the community.

Therefore Be It Resolved that CDEC30 accepts and approves the following re-zoning plan for Jackson Heights and zoning for New School 398 as submitted by Community Superintendent Dr. Composto:

Zoning Line Proposal Submission

Submitted to CEC 30 October 5, 2018

1. Goals of the proposal: The New York City Department of Education (NYCDOE) and the District 30 Community Education Council (CEC 30) have identified a need to change the current zone lines for P.S. 69, P.S. 148, P.S. 149, P.S. 152, P.S. 212, P.S. 222, P.S. 228, P.S. 280, and P.S. 89 (District 24) in order to create a new zone for the elementary school that will open in Q398 and to alleviate overcrowding at elementary schools in the Jackson Heights neighborhood.

2. Schools affected by the proposal: P.S. 69, P.S. 148, P.S. 149, P.S. 152, P.S. 212, P.S. 222, P.S. 228, P.S. 280, and P.S. 89 (District 24)

3. Effective date for implementation: This plan would be implemented for admissions to the 2019-2020 school year for incoming pre-kindergarten, kindergarten, or new students to the system. The existing zones for students in grades 1-5 at any impacted school will remain the same while the proposed zones will phase in along the following timeline:

2019-2020: Pre-kindergarten, kindergarten, and students newly enrolling in DOE schools. 2020-2021: Pre-kindergarten, kindergarten, Grade 1, and students newly enrolling in DOE schools 2021-2022: Pre-kindergarten, kindergarten, Grades 1-5, and students newly enrolling in DOE schools **4.  - Start at the corner of Northern Boulevard and 94th Street; then
 - 2. East on Northern Boulevard to 96th Street; then
 - 3. South on 96th Street to 34th Avenue; then
 - 4. East on 34th Avenue to 97th Street; then
 - 5. South on 97th Street to 35th Avenue (excluding both sides of the street); then
 - 6. West on 35th Avenue to Junction Boulevard; then
 - 7. Southeast on Junction Boulevard to 37th Avenue; then
 - 8. Southwest on 37th Avenue to 94th Street; then
 - 9. North on 94th Street to 35th Avenue; then
 - 10. West on 35th Avenue to 93rd Street; then
 - 11. North on 93rd Street to P.S. 280; then
 - 12. East to 94th Street (between P.S. 280 and 34-10 94th Street); then
 - 13. North on 94th Street to Northern Boulevard (the point of origin).
- g. The addresses contained in the following area would be in the new P.S. 89 zone:
 - 1. Begin at the intersection of 84th Street and 37th Avenue; then
 - 2. East on 37th Avenue to 91st Street; then
 - South on 91st Street to Elmhurst Avenue; then
 - 4. Southwest on Elmhurst Avenue to Gleane Street; then
 - 5. East on Gleane Street to Whitney Avenue; then
 - 6. South on Whitney Avenue to Judge Street; then
 - 7. West on Judge Street to Baxter Avenue; then
 - 8. South on Baxter Avenue to Woodside Avenue; then
 - 9. West on Woodside Avenue to 78th Street; then
 - 10. North on 78th Street (through the Elmhurst Hospital Center and continuing on 78th Street) to Roosevelt Avenue; then
 - 11. East on Roosevelt Avenue to 83rd Street; then
 - 12. Continue East on Roosevelt Avenue to 84th Street (including both sides of the street); then
 - 13. North on 84th Street to 37th Avenue (including both sides of the street) (the point of origin).
- h. The addresses contained in the following area would be in the zone for the new school at Q398:
 - 1. Start at the corner of Brooklyn-Queens Expressway and Northern Boulevard; then
 - 2. East on Northern Boulevard to 79th Street; then
 - 3. South on 79th Street to 34th Avenue; then
 - 4. West on 34th Avenue to 78th Street; then
 - 5. South on 78th Street to 35th Avenue; then
 - 6. West on 35th Avenue to Brooklyn-Queens Expressway; then
 - 7. North on Brooklyn-Queens Expressway to Northern Boulevard (the point of origin).

- 7. A statement of how students will be admitted to the affected schools: The proposed changes would impact only incoming pre-kindergarten or kindergarten students that are new to the system in 2019-2020. All currently enrolled students may remain in their school. Children entering pre-kindergarten and kindergarten with a currently zoned sibling in grades K-5 at P.S. 69, P.S. 148, P.S. 149, P.S. 152, P.S. 212, P.S. 222, P.S. 228, P.S. 280, and P.S. 89 (District 24) will maintain their zoned sibling priority.
 - a. Students will be enrolled in New York City pre-kindergarten programs by the following priority:
 - Students residing in the zone, who have a sibling pre-registered or enrolled at the time of application submission and will be enrolled in grades K-5 in the school at the start of the following school year.
 - 2. Students residing in the zone, who do not have a sibling at the school.
 - 3. Students residing in the district, who have a sibling at the school,
 - a. who have no zoned school or whose zoned school has no pre-K program, then
 - b. who are zoned to a different school which has a pre-K program. Students residing in the borough, who have a sibling at the school.
 - 4. Students residing out-of-borough, who have a sibling at the school.
 - 5. Students residing in the district,
 - a. who have no zoned school or whose zoned school has no pre-K program, then
 - b. who are zoned to a different school which has a pre-K program.
 - 6. Students residing in the borough.
 - 7. Students residing out-of-borough.
 - b. Students will be enrolled in New York City elementary schools by the following priority:
 - Zoned students whose verified siblings are pre-registered or enrolled at the time of application submission and will be enrolled in grades K-5 in the school at the start of the following school year
 - 2. Zoned students other than those in (1) above applying to the zoned school
 - Students whose verified siblings are pre-registered or enrolled at the time of application submission and will be enrolled in grades K-5 in the school at the start of the following school year who are not zoned to the school,
 - a. Within District first, then
 - b. Out of District
 - Students currently attending the school's pre-kindergarten program who reside outside the school's zone, without a sibling who will be in grades K-5 at the school in the following school year,
 - a. Within District first, then
 - b. Out of District
 - 5. Students other than those in (3a) and (4a) above who are residents of that district
 - 6. Students other than those in (3b) and (4b) who are residents of another district
