We're gonna discuss, you know. 02:07:07.000 --> 02:07:15.000 How we've historically done this or if there's schools that you're interested in, you know, these are things that we would talk about as a council. 02:07:15.000 --> 02:07:24.000 I think when we did last time we kind of share the list and people kind of picked. What they wanted and you know that's how it went and it was very good you know it was nice everybody was mice about it. 02:07:24.000 --> 02:07:26.000 So people didn't get every school they wanted. Marcela, there's something you want to add. Marcel is very active in the community here on my side of town. Why not? 02:12:08.000 --> 02:12:14.000 Just have that relationship with them. 02:12:14.000 --> 02:12:22.000
