Decision-making. This year our office has allocated a million dollars in capital funding. That can be used for physical infrastructure projects.

And this year along with another 27 council member offices were participating in the so that means 28 million dollars will be decided by all the community members around New York City on how to where to spend this money.

in the idea collection and volunteer recruitment phase which is October to November and in the past few weeks our office has hosted several neighborhood assembly that's the information session for anyone who's interested in learning about the PB or get involved.

I also went to a school at IS 2 30 to present to their class, that the students are interested in knowing about the process and want to get involved.

So under the PB, we're generally talking about the Capitol project, which covers the brick immortal project, which is more like a long-term investment into facility and infrastructure. 00:32:40.000 --> 00:32:49.000 And expense is usually less expensive and also you should cover the people in the services. And I have a few example here to make it clear for you. 00:32:49.000 --> 00:32:58.000 So for example, Capital, it can mean technology upgrades. You can upgrade the school computer lab. 00:32:58.000 --> 00:33:04.000 You can upgrade the computer iPads or other technology upgrades. You can do auditorium upgrades. 00:33:04.000 --> 00:33:14.000 It can be for trees and tree guards. It can be water fountain installation. And what's not eligible under PV will be expense. 00:33:14.000 --> 00:33:25.000 For example, street cleaning, buying snacks for after school program, renting a space for community groups or running a basketball league. 00:33:25.000 --> 00:33:36.000 And then here's some. For what can be qualified under PB. One is that they need to cost at least \$50,000. 00:33:36.000 --> 00:33:56.000 But they cannot be more than 1 million dollars. The reason being that we only have 1 million dollars allocated for this whole purpose so we usually try to fund not just one project and then they need to have a lifespan of at least 5 years but there's the exception is that if it's for school, technology upgrades. 00:33:56.000 --> 00:34:03.000 I think the rule 3 years because no iPads or phone or laptop can last more than 5 years at this point. 00:34:03.000 --> 00:34:04.000 Yeah. 00:34:04.000 --> 00:34:11.000 And then this also too tricky thing is some project might. Might be a

capital project but they can be either too cheap or too expensive.

00:34:11.000 --> 00:34:20.000 For example, replacing one fallen tree or installing a stop sign or purchasing trash can, that's not gonna cost more than \$50,000.
