It's a big job. 00:17:44.000 --> 00:17:55.000 Devon. Walton is the assistant she supports myself, and Sam Abbasi, who supports the districts in the South 2728 and 29. 00:17:55.000 --> 00:17:59.000 I will share my screen, let's see if I could do it. 00:17:59.000 --> 00:18:04.000 I wanna thank Gail. 00:19:19.000 --> 00:19:31.000 Get the training and emergency readiness. So some of you, wondering why every 2 years well, things change.

00:19:31.000  $\rightarrow$  00:19:32.000 We may see a protocol that needs to be adjusted.

00:19:32.000 --> 00:19:41.000 It may be a new protocol that we implement. So it's always really good to do it.

00:19:41.000 --> 00:19:47.000 Every 2 years. So things say fresh people don't forget, and everyone's in the loop so let's say that there's a new principal who comes on in March.

So throughout the 5 boroughs borough Safety Directors invite their districts once a month to go over current trends and guests and professional learning opportunities for our districts, and it is an engaging time where schools may have a question or a problem to resolve you know sometimes

00:22:36.000 --> 00:22:42.000 So we do things in generic form. But once we learn from staff, hey, we need to work on this.

We implement these protocols when there's an emergency and each emergency requires a different protocol. 00:23:28.000 --> 00:23:44.000 Sometimes it may require 2. So what we do is we tell the school community using the PA system and since we've already done the training with our children, and we do the drills, our staff and students know what to do. 00:23:44.000 --> 00:23:51.000 So our red in the lockdown software hard means that there's a threat in the building. 00:23:51.000 --> 00:23:57.000 And what we say over the PA system is attention. We are in a soft lockdown. 00:23:57.000 --> 00:24:06.000 Take proper action. Well, what is that proper action? It means that inside our classrooms teachers lock their doors. 00:24:06.000 --> 00:24:15.000 Teachers, students go in the hiding corner to shut the lights and would be quiet, and we'll wait for next steps. 00:24:15.000 --> 00:24:26.000 Okay, so the difference between soft and hard lockdown is that hard lockdown means the threat is imminent in the building. 00:24:26.000 --> 00:24:29.000 What does that mean by imminent? It's imminent. 00:24:29.000 --> 00:24:33.000 We don't move the sweet Teams. I'll talk about that in a minute. 00:24:33.000 --> 00:24:36.000 The suite teams are not. 00:24:36.000 --> 00:24:37.000 Walking around. We are in place, and we're waiting for Nyp. 00:24:37.000 --> 00:24:48.000 Response that may take up to 2Â min. Right? So again. So there's a threat in the building. 00:24:48.000 --> 00:25:01.000

We'll take proper action, but I'll suite teams go walking around, and that's how we drill but a hard lockdown meeting there's an imminent threat in the building. 00:25:01.000 --> 00:25:06.000 No one moves, no sweep teams, and we wait for Nypd to come in. 00:25:06.000 --> 00:25:15.000 Okay. Everything. Getting confused. Because I think people they think that shelter in. And I'll go over that right now. 00:25:15.000 --> 00:25:23.000 The threat is outside the building that could be a multitude of things. I could just think of. 00:25:23.000 --> 00:25:27.000 Last week there was a bank robbery. There was someone would have done. 00:25:27.000 --> 00:25:34.000 There was this, that any other, and when these threats come through, citizens app cause, that's not always accurate. 00:25:34.000 --> 00:25:46.000 We sometimes the precinct themselves will call the school and say, Please shelter in place, and what that means is that staff is trained to respond to all the doors. 00:25:46.000 --> 00:25:54.000We lock the doors, and we wait for the All clear from Nypd. 00:25:54.000 --> 00:25:58.000 When we're in the building for the sheltering people responding to your doors. 00:25:58.000 --> 00:26:01.000 But as business as usual, that means that kids are still learning. 00:26:01.000 --> 00:26:15.000 They're walking around businesses usual. And in the PA system we say, Attention, this is a shelter in secure the exit doors. 00:26:15.000 --> 00:26:19.000 An evacuation could be a multitude of things. 00:26:19.000 --> 00:26:25.000 This is something we're all really familiar with, because we did it as children as well. 00:26:25.000 --> 00:26:31.000 We leave the building. Fire alarms will go off, and the PA system is used. 00:26:31.000 --> 00:26:41.000

Sometimes to give specific directions. That's it's not always an easy one, but I'll get to the hold in a minute. 00:26:41.000 --> 00:26:52.000 The hold is a new part of the general response. Protocol and it's initiated to manage an incident in the building that does not place the school community in danger. 00:26:52.000 --> 00:27:04.000 It's business. As usual. We go over the PA system and say, Attention, this is a hold well, staff and students and visitors remain where you are until there's an all clear well, what what do you use a hold for? 00:27:04.000 --> 00:27:08.000 You can use a whole for. 00:27:08.000 --> 00:27:14.000 A student has a very, heavy, heavy, heavy, nosebleed, and you need to contain a stairwell. 00:27:14.000 --> 00:27:28.000 It could be a staff member that fell, or it could mean a student in crisis where you know, the student needs that privacy in public, and we could put the hold. 00:27:28.000 --> 00:27:42.000 And you initiate it there. It's one of my favorite protocols, because in buildings things happen where we have to transition, sometimes we can call a whole. 00:27:42.000 --> 00:27:46.000 But we, we may have to elevate to a laptop. 00:27:46.000 --> 00:27:47.000 We may do a hold, and say, ladies and gentlemen, we're going to evacuate the building. 00:27:47.000 --> 00:28:00.000 So sometimes it's allows us to put a stop to movement in order to move into another protocol. 00:28:00.000 --> 00:28:05.000 If need be, and it allows us to provides some dignity. 00:28:05.000 --> 00:28:09.000 Sometimes in our buildings, when emergencies happen to people, whether you're sick, you're fainted, you're bleeding. So on. 00:28:09.000 --> 00:28:17.000 And so forth. 00:28:17.000 - > 00:28:24.000Our emergency drills. So New York State law requires 12 emergency Drills.

The formula is simple. 8 and 4 in your mind. 00:28:27.000 --> 00:28:37.000 84, their 8 evacuation drills that we have to practice as per the state and 4 lockdown drills that we have to practice in New York City. 00:28:37.000 --> 00:28:43.000 We divided up into what are those States? September through October? 00:28:43.000 --> 00:28:49.000 We have to do one mandatory lockdown address. 00:28:49.000 --> 00:28:53.000 Within that timeframe from September to December 30. 00:28:53.000 --> 00:29:01.000 First, we can conduct up to 7 emergency drills. So that is a combination of evacuation. 00:29:01.000 --> 00:29:11.000 Drills and lockdown drills, but by the by 4 we go on vacation for the holiday season we must complete 7 additional drills. 00:29:11.000 --> 00:29:17.000 That's 8. 8 gotta be done. You could do 2. 00:29:17.000 --> 00:29:21.000 You could do. 6, 6. Evacuations to Lockdown by the holiday. 00:29:21.000 --> 00:29:26.000 Season. In December, when we get back in the fall. 00:29:26.000 --> 00:29:39.000 We don't tend to do evacuation drills in the winter, because it's cold, but between February and March fifteenth we must conduct one lockdown drill, and then we have the 3 additional drills. 00:29:39.000 --> 00:29:46.000 By June and this is monitored, and we send out clients information to schools. 00:29:46.000 --> 00:29:53.000 So they are. Make sure they are on their target and they're memorializing this in the ores system. 00:29:53.000 --> 00:30:05.000 In a timely fashion, so once they do a drill, they have to put it into ores within 48Â h of the drought, and with the drills our Br team members wear their best. 00:30:05.000 -> 00:30:12.000So children and staff know coffee if something happens in an evacuation drill and you wouldn't believe it.
