Hi, my Name's Kate makin I am the parent of a child at is 2 30 and i'm also a professor at Queens College, and I wanted to point out to everybody on the Council there was a 01:31:44.000 --> 01:31:51.000 report, you know, just like we have our district cec there's a citywide council on the education of English language learners. 01:31:51.000 --> 01:32:03.000 And that council issued a report, and it showed that large numbers of students who are learning English in our school district. 01:32:03.000 --> 01:32:12.000 Who are entitled to receive bilingual education under New York State policy are not receiving bilingual education. 01:32:12.000 --> 01:32:17.000 Now bilingual education is when students are educated in their home language. 01:32:17.000 --> 01:32:25.000 In addition to English, while they're learning and the research is very clear that this is the best possible approach for students to learn the English language. 01:32:25.000 --> 01:32:35.000 I understand That might be a sort of counterintuitive idea to some people, but when you engage the home language practices of students, all the research is quite clear. 01:32:35.000 --> 01:32:45.000 At this stage in 2022 that students that outcomes are far better when students have the opportunity to learn in their home language. 01:32:45.000 --> 01:32:55.000
