So we would like to begin by providing you with an introduction to who we are. And then providing you with an overview of our proposed engagement with the Long Island City Planning process.

So, at Siebel, we really have a two part mission.

and consulting projects, and it is through that partnership, which now spans more than 150 projects that we've seen those folks that we work with, we call them our clients.

Second, we offer a program that prepares graduate students for careers, leading school systems and nonprofit organizations, through our semester long program, as you can imagine for this evening.

I'm going to focus a little bit more on our research and consulting services, but it is really the combination of these two components that we hope will serve our long term vision to expand access to high quality education for all students, but especially

So, how we go about pursuing that mission and vision is deeply shaped by our six core values, you can see the first three here on the screen, we use these core values to think about our clients problems and our clients goals, and these clients may be

state agencies, school districts family focused and community based organizations, among many others. As an example, nearly every year of our existence, we have partnered with the New York City Department of Education, so many of our clients are those

stakeholders. So when we're thinking about the stakeholders we're thinking about projects. We really strive to gather information about those people in their experiences, and we're often doing that directly meeting with principals, teachers, students,

as meaningful engagement. So in order to hit those different benchmarks. It's important that we begin with some stakeholder mapping and research to really name specific communities and groups that will be impacted by the planning process.
