• State Accountability and Parent Notification

In accordance with the New York State's accountability system and consistent with federal Elementary and Secondary Education Act (ESEA) requirements, schools designated as focus or priority are required to send out a parent notification letter regarding the school's accountability designation for the 2018-19 school year by Friday, September 28, 2018. Ensure Staff Complete Emergency Response Training

In accordance with the NYS Law 2801, all Department of Education school and non-school based staff must complete the annual training on emergency response protocols. September 15th is the deadline date when this training had to be completed.

Designate a Language Access Coordinator

School officials were asked to designate a staff member to serve as their school's Language Access Coordinator (LAC) in order to support Limited-English Proficient (LEP) parents. The designated member must meet the criteria set forth by the DOE.

<u>Distribute Vision Screening Letter and Handout to Parents</u>

In accordance with DOE Policies, in ATS for all students. Schools will be contacted by a member of the vision screening team from the NYC Department of Health and Mental Hygiene (DOHMH) in order to schedule the screenings for students in pre-k, kindergarten, and first grade. **Note**: school officials/staff are required to conduct screenings for students in all other grades that are not screened by DOHMH. In preparation to meet this requirement, schools officials are asked to distribute the <u>Vision Screening Letter</u> and the <u>Vision handout</u> to parents, which are available in <u>all DOE languages</u>. The letter explains the importance of vision screening in school, and the handout describes the signs of vision problems in young children.

The DOE in partnership with the New York City Public Library, encourages schools and their staff to backpack home the attached flyer about upcoming open house events at the New York Public Library in Manhattan, the Brooklyn Public Library, and the Queens Library on **September 29**.
