#### **Respect for All Winners**

This year, the theme of the essay contest was "From Bystanders to Allies." Essays had to address one of the following prompts;

1. Describe a time when you stood up for someone other than yourself. Explain how this act or acts have affected your life.

2. Describe a time when someone has helped you in a time of need. Explain how their actions have affected you.

3. Why do you think people have trouble accepting others who are different from them? How can you encourage others to be more accepting of those who are different?

4. The end of bullying begins with you: What have you (or someone you know) done to inspire, involve, or help others in preventing or ending bullying? Please give examples.

The theme of the poster contest was "Friends do make a difference." Students had to create a poster that incorporated their experience and understanding of bullying and anti-bullying. The intent of this contest was to raise awareness around bullying issues through the healing power of art. Art helps to tell stories, express pain, and share hopes. The posters could reflect any of those perspectives.

- Dress Codes

Chancellor's Regulation A665 speaks to developing a uniform policy in schools and does not apply to schools unless they have a uniform policy. As such, all dress codes in NYC DOE must conform to this guideline.

Schools may develop dress codes in accordance with Chancellor's Regulation A-665 and in compliance with applicable federal, state, and city laws and regulations.

However, schools may not develop gender-specific dress codes (e.g., require only girls to wear skirts). Dress codes must be written, enforced, and applied equally to all students regardless of gender and must be free of gender stereotypes.

For example, where a school seeks to prohibit revealing clothing, the school should use gender-neutral language such as "clothing that does not provide coverage of torso, undergarments and private parts, including see-through clothing" as opposed to prohibiting "distracting" clothing or certain types of clothing which are stereo-typically associated with one gender (e.g., a mini skirt). Furthermore, a school cannot require gender-specific attire for yearbook photos and graduation or other school-sponsored activities. Additionally, a school must not prohibit a student from maintaining or wearing natural hair or hairstyles that are closely associated with their gender, race, ethnicity, religion, disability, or other protected identity, or in a manner that discriminates against them on any of these bases.

To support the schools, the following dress code template can be adapted and used:

"In order to maintain a positive learning environment, it is expected that [school] students dress in a professional manner. We expect [school] students to be dressed appropriately to ensure safety and to keep the focus on teaching and learning. We would like all parents and guardians to remind students of proper dress protocols on campus.

Prohibited forms of dress at [school] include, but are not limited to:

- 1) Hats or caps (with the exception of headwear worn for religious observance).
- 2) Clothing that contains references to drugs, alcohol, sex, violence, racism, or gang-affiliation.
- 3) Clothing that does not provide coverage of torso, undergarments, and private body parts, including see-through garments of any kind.
- 4) Flip-flops.
- 5) Sunglasses while indoors.

If a student comes to school wearing clothing prohibited by the Dress Code, then the student's parents will be notified, the student may be subject to the interventions and disciplinary responses set forth in the Discipline Code, and the student will be expected to make appropriate adjustments to his/her clothing to conform with the Dress Code (e.g., turning shirt inside out, borrowing temporary clothing until the end of the school day, etc.)."

### • CEC - Brilliant NYC Follow-up

On the evening of the Brilliant NYC meeting, Learning Times, the vendor that the DOE hired, experienced technical difficulties due to the large of "live" participants. On that evening, the presentations went well, however, when the vendor tried to place participants into break-out groups the system was overloaded and only 500 participants were able to be placed in breakout rooms. When that occurred, we tried contacting the management team of the vendor by phone, without success. After approximately twenty minutes my team and I jumped in and facilitated a whole-group session with many participants sharing, either orally or in the chat.

Due to this technological difficulty, our professional and caring principals agreed to hold a second opportunity of breakout groups so all families interested in sharing had an opportunity to have their voice heard and their thoughts and ideas included in the information being shared with our central office. The dates and times of these meetings are attached. Due to this effort, we have received over 1,000 comments so far from our District 30 families. Following the event several families also e-mailed to thank me for facilitating the large group and for also arranging another opportunity for them to meet in their school communities.

We did share with central our concerns about the company hired to manage the Zoom conference. Some participants did not receive the link from Learning Times after registration, others received the link with the incorrect start time of 6pm when the meeting was scheduled for 6:30pm. As a result, my team had to personally send invitations to families that e-mailed us stating they did not receive the link. The vendor should have known limitations of the Zoom, particularly since the anticipated volume of participants was the reason they were hired.

#### 2021–22 Student Perception Survey Now Open

The administration window for the 2021–22 Student Perception Survey is now open through January 21. All students in schools that have any grade from 6–12 can access the survey by visiting the Student Perception Survey site. Survey coordinators and principals received an email on December 2, containing directions for administration, lists of eligible teachers, and student access codes; the survey will be administered online only.

The survey is administered for formative purposes and is not administered as a part of the New York City's system for teacher development and evaluation.

#### Expanded COVID-19 Vaccine Mandate for Students Ages 5–11 in High-Risk Sports and Activities

The current COVID-19 vaccine mandate for students participating in high-risk extracurricular activities has been expanded to include students ages 5–11.

This mandate includes all high-risk extracurricular activities, including those hosted by Community Based Organizations (CBOs) and external agencies, taking place in DOE buildings. With regards to athletic activities, this mandate applies to students participating in competitive sports, meaning activities where students play against students from other school communities. Specifically:

- High-risk competitive sports as designated by the CDC/NYSED/NYSDOH, which are football, volleyball, basketball, wrestling, lacrosse, stunt, and rugby. Vaccination will also be required for participation in bowling, because while not a high-risk sport, it takes place in spaces that require vaccination for children ages 5 and older.
- Extracurricular activities scheduled outside of the school day, like singing/chorus, orchestra/marching band, musical theater, dance, and cheerleading/step teams/flag teams.

Students who wish to continue to participate in these extracurricular activities must get their first dose of the COVID-19 vaccine by December 14. Please note that if a rehearsal, performance, or exhibit is connected to in-school required arts instruction or class curriculum, no student vaccine is required. Note that the list of high-risk activities has not changed since the announcement of the vaccine mandate for all students and staff participating in high-risk PSAL sports.

#### Updates to Chancellor's Regulation A-660

The Office of Family and Community Empowerment (FACE), in partnership with the Chancellor's Parent Advisory Council (CPAC), has successfully amended Chancellor's Regulation A-660. The updated version of Chancellor's Regulation of A-660 can be <u>viewed here</u>. We are proud of the work that our Parent Associations (PAs) and Parent Teachers Associations (PTAs) were able to conduct throughout the pandemic, and the new policy changes ensure that those successful practices endure. Below is a summary of the most important changes:

- Eligibility for membership in PAs/PTAs has been expanded to include parents of students attending a 3K or pre-K program offered by a school under the jurisdiction of the community school district.
- PAs/PTAs and Presidents' Council meetings may be conducted in-person, on a virtual remote platform (VRP), or in a hybrid format.
- PAs/PTAs and Presidents' Councils may make payments using paper checks, electronic checks directly debited from the checking account or, in exceptional circumstances, a debit card.

As a companion document, FACE has also issued a policy implementation memorandum that guides PAs/PTAs and Presidents' Councils in operationalizing changes related to financial transactions. Below are the salient points:

- PA/PTAs and Presidents' Councils must adopt procedures to ensure that online and debit card transactions are properly authorized and documented.
- They also must pay special attention to fraud-control mechanisms (see memo).
- Debit card transactions require membership authorization of both the expenditure and the method of payment; and they must be recorded on the Debit Card Disbursement Form.
- Debit card transactions in excess of \$5,000 require notification to the principal and FACE (in the case of a PA/PTA) or the superintendent and FACE (in the case of a Presidents' Council.
- Person-to-person or instant payment systems such as Venmo and Zelle may be used to receive donations, provided they are linked only to the PA/PTA or Presidents' Council DOE-issued email address. Under no circumstance should they be used for making payments.

FACE has begun offering trainings on the new regulation to Family Leadership & Support Coordinators (FLCs/FSCs). In Collaboration with the Chancellor's Parent Advisory Council, we are excited invite PA/PTA Members and Presidents Council Members to trainings on December 14th, 15th and 16th.
