Guidance for Outdoor Play in Cold Weather

Children benefit from vigorous exercise and should be given the opportunity to play outside whenever possible. Unless it is snowing, or there is ice on the playground, or the wind chill factor produces an effective temperature below zero degrees Fahrenheit (-18 degrees Celsius), temperature alone should not be a barrier to outdoor play. Principals are encouraged to work with their staff to maintain outdoor play periods, and they should take precautions to keep students warm and to ensure that they are appropriately dressed on very cold days.

When outdoors, school officials must ensure that their students and staff cover exposed skin, wear warm clothing, and use multiple layers to maintain warmth. Students that need to avoid the cold weather for medical reasons must submit a note from their health care provider to the school nurse.

Prepare for Summer in the City (SITC) 2020

As in previous years, Summer in the City (SITC) will continue to provide rigorous and engaging summer learning opportunities to both mandated and non-mandated students in core content: math, literacy, and STEM.

Charter School Mailings Notice and Removal Form

In response to parent concerns, the DOE is offering all parents the option to remove their names from charter school mailings produced by Vanguard; families may refuse mailings online or by using the paper form. If schools have new students or students who have not yet completed a form, schools should ensure forms are completed by January 17th. School officials should also continue to complete this process for newly enrolled students throughout the school year.

<u>Present FY 2021 Fair Student Funding Budget Allocations to Community and Citywide Education Councils</u> (CCECs)

Superintendents, BCO directors of finance and human resources, and district budget representatives should review the following information on the FY 2021 Fair Student Funding (FSF) budget: Every spring, the Panel for Educational Policy (PEP) votes on the DOE budget allocation formula for the following fiscal year. In preparation for this event, superintendents must present the DOE's proposed FSF budget allocations for FY 2021 to all Community and Citywide Education Councils (CCECs), between **February 17** and **April 3**.

3-K and Pre-K Admissions Timeline for the 2020–21 School Year

The 3-K and pre-K application period for the 2020–21 school year will open on **February 5**. The deadline for families to submit their pre-K application will be **March 16**. The deadline for families to apply to 3-K will be **April 24**.

Kindergarten Admissions Applicant List and Sibling Verification

The deadline for families to submit a kindergarten application is **January 21**. Schools will receive a list of their current pre-K students who have not yet applied to kindergarten. The school's deadline to complete sibling verification in MySchools is also on **January 21**.
