First Public Comment and Speaking Time

Presentation – Office of Language Access

Robert Williams, the parent point person for OLA, wants to help parents navigate the website and secure available resources. Over 180 languages are spoken in schools, and approximately 40% of households speak a language other than English at home. The top nine non-English languages are Arabic, Bangla,

Chinese, French, Haitian Creole, Korean, Russian, Spanish, and Urdu. Following English, Spanish, Bangla, and Arabic are the top languages in District 30. Portuguese is rising. Translation and Interpretation Request Forms are available in the top nine languages. These services are available to Parent Associations if there is a demonstrated need. Resolution 179 Requesting No Remote Instruction When Schools Close for a Temporary Emergency

Nick Masson read the resolution. Members discussed the resolution. Jonathan Greenberg stated that remote instruction is required because the state mandates a minimum number of days for instruction. He suggested an edit to state "the onset of the COVID-19 pandemic." Additionally, after discussion, another amendment was proposed, "**THEREFORE, BE IT FURTHER RESOLVED**, that the District 30 Community Education Council urges the NYC Public School System if mandatory remote learning days continue, to not penalize children with absences if they are unable to connect to any mandatory remote learning day."

Kelly Craig motioned to put this resolution on next month's agenda, so the public can review it. Jonathan Greenberg seconded.

2024 Summer Youth Employment Program (SYEP) Lottery and 2023 SYEP Data

All students ages 14–24 are invited to apply to participate in the <u>2024 Summer Youth Employment</u> <u>Program (SYEP)</u>, which is now accepting <u>applications</u> for summer 2024 via the general lottery through **March 1**. Please share the program flyer with your school community and encourage your students to apply. For questions, email <u>SYEP@schools.nyc.gov</u>.

Additional Guidance for Students with IEPs for the SYEP Application: As in previous years, you and your staff are encouraged to support students with Individualized Education Programs (IEPs) and 504 Plans with the application process. Interested students should follow this <u>TCAC Online Application</u> <u>Guide</u> and submit an <u>online application</u> for their age group through their borough's <u>Transition and</u> <u>College Access Center (TCAC) office</u> by 5:00 p.m. on **March 1**. TCACs will support students with IEPs and 504 Plans with the necessary information to be added to their applications in order to receive targeted support for placement in the TCAC-specific lottery; this enhances their chances of being placed in their respective borough and program choice. In addition, note the following:

- Students ages 16–21 should submit a completed SYEP Older Youth Participant Application; and
- Students ages 14–15 should submit a completed paper <u>SYEP Younger Youth Participant</u> <u>Application</u>.

Distribute IDNYC Applications to High School Students

In accordance with Local Law 48, schools are required to distribute information on IDNYC applications to high school students by **March 1**. Launched in 2015, IDNYC is a card for all New Yorkers, regardless of immigration status. The free, municipal identification card provides access to a wide variety of <u>services</u> and programs offered by the City. For cardholders age 16 and older, cards are valid for five years from the date the application was approved. For cardholders under the age of 16, cards are valid for two years from the date the application was approved.

To acquire an ID, high school students can make an appointment through the <u>IDNYC online portal</u> or can visit a site accepting walk-in applicants. For additional information on IDNYC including a FAQ, review the <u>IDNYC online portal</u>.

As a reminder, the DOE does not ask about or track student immigration status, and any and all resources must be made available to all students and families.

Respect For All Week

This year's Respect for All (RFA) Week will take place from **February 12–16**. During RFA Week, school officials should celebrate, highlight, and build upon ongoing diversity programs and curriculum-based instruction. They should develop new initiatives that promote respect for diversity and engage students in meaningful lessons and/or other activities that focus on preventing bias-based harassment, intimidation, and/or bullying.

For suggested daily themes, refer to this <u>flyer</u>. Topics include, but are not limited to, celebrating kindness; being an ally; combatting and reporting bullying and cyber-bullying; respect for diversity, disability, and religious acceptance; respecting gender identity and gender expression; and LGBTQ pride and acceptance. Additionally, school officials are asked to share with families and guardians the RFA week <u>video</u> with translated captions and the <u>Respect For All flyer</u> (available in all <u>DOE languages</u>) with resources for students and parents.

Prepare to Administer the 2024 NYC School Survey

All 3–K/pre–K and K–12 families, teachers and support staff, and students in grades 6–12, will be invited to take the annual NYC School Survey starting on **February 12**.

Pandemic Electronic Benefit Transfer Program (P-EBT)

The <u>Pandemic Electronic Benefit Transfer Program (P-EBT)</u> is a federal program to provide food benefits to children who miss the opportunity to receive school meals due to pandemic-related school closures. These benefits take the form of funds on electronic benefit transfer (EBT cards), which can be used in the same manner as SNAP (food stamp) cards. All children who were enrolled in DOE schools during the 2021–22 school year, Summer 2022 or during Summer 2023 school programming are eligible for this benefit.

At this time, many parents/guardians have not yet utilized these benefits, with millions of dollars currently unspent. These dollars can still be spent on food, and some of these benefits may be expiring soon. To ensure parents are made aware of this benefit, please ensure that your parent coordinators <u>distribute</u> <u>this letter</u> to families, which includes translations. Please note that this is <u>not a DOE program</u>. Message from Chancellor Banks

Promoting Respect in NYCPS

Dear New Yorkers,

I've been thinking a lot recently about respect. It's a value I've always tried to both model and instill in those around me—as a father, teacher, principal, and now as Chancellor. Respect is at the foundation of all strong communities, including our schools. And it's needed now perhaps more than ever.

As the crisis in the Middle East continues, and many students, staff, and families are experiencing deep pain and fear, respect for our shared humanity is critical, a message I emphasized in recent <u>remarks</u> as we announced our <u>plan</u> to combat hate in NYCPS.

I also highlighted respect at the recent Gender and Sexuality Alliance (GSA) Summit, hosted at Midwood High School, where approximately 1,300 students and staff representing <u>GSA clubs</u> from across the city joined together to support and celebrate the LGBTQ+ community.

And now we have another opportunity to discuss, emphasize and demonstrate respect at our annual Respect for All (RFA) Week. During RFA Week, which takes place February 12-16, schools lead programming that promotes belonging, honors diversity, and fights bullying and harassment. Schools have planned a wide range of creative activities this year, from no bullying pledges to a diversity celebration parade, from student-moderated panels to pronoun button workshops. PS 305 in Queens is even planning a wax museum, where some students dress as historical figures representing a wide range of identities, and other students visit the "museum" to learn about them!

I encourage families and staff to explore the Respect for All resources on our <u>website</u>, including information on how to report bullying if it does occur and instructions for identifying your school's RFA liaison, who is the point person for any bullying or harassment concerns. And next week, as we celebrate and uplift respect, use the #RespectForAllWeek and #RespectForAll hashtags to share photos and videos of the great work you are doing.

We speak over 180 languages in NYC Public Schools. We have students and staff of every identity and background. Let's celebrate that beautiful tapestry—during RFA Week and year-round.
