NYSAA Overview

New York State Alternate Assessment (NYSAA) Students

The NYSAA is part of the NYSED testing program that measures student performance on alternative achievement standards in the areas of ELA, Math and Science for students with the most severe cognitive challenges. The CSE determines whether a student with a severe cognitive disability is eligible to take the NYSAA.

Eligible students are assessed as follows:

- Using Dynamic Learning Maps (DLM) computer based testing (CBT).
- ELA and Math: in grades 3-8 and one time at the secondary level prior to exiting HS.
- Science in grade 8 only this year and one time at the secondary level prior to exiting HS.
- Students are assessed using a series of testlets in ELA, math, and science depending on grade level and content area.
- Students are assessed according to *AGE* and not necessarily their ATS grade.

The New York State English as a Second Language Achievement Test (NYSESLAT) is designed to annually assess the English language proficiency of all English Language Learners (ELLs) enrolled in Grades K– 12 in New York State schools. The test provides the State and schools with important information about the English language development of ELLs and is part of the State's compliance with federal laws that mandate the annual assessment and monitoring of the English language proficiency of all ELLs.

Grades 3-8 NYS Assessments Overview

These tests are required by the federal Every Student Succeeds Act (ESSA) and are designed to provide important information about whether students are prepared to progress through school and graduate with the critical thinking, problemsolving, and reasoning skills they need for long-term success in school, college, and careers, and to support students in their pursuit of economic security and a choice-filled life.



Grades 3-8 NYS Assessments What do the tests entail?

- Each test consists of two untimed sessions and is administered over two days (one session per day).
- Session 1 and 2 for ELA include multiple-choice and openended questions.
- Session 1 for Math is multiple-choice only. Session 2 for Math includes multiple-choice and open-ended questions.



Grades 3-8 NYS Assessments How long does my child have to complete a state exam?

State tests are untimed. Students who need more time will be able to work at their own pace to better demonstrate what they know and can do.

Although testing duration will vary among students, the table below estimates the average time it will take students to complete each session of the exam.

Grades 3-8 NYS Assessments How do State tests benefit my child?

You and your child benefit from State tests because they:

- Provide detailed information about whether your child is learning what is expected of them for their grade levels.
- Help schools determine how students are progressing and performing compared to their peers, and which students or teachers may need more support.
- Allow you to learn how your child's school is doing compared to other schools.



Grades 3-8 NYS Assessments Can I opt my child out of State tests?

- We strongly encourage all students to take these tests because both you and your child benefit from the information we learn through test results. State tests provide additional information on what your child is learning and help teachers and schools adjust support where needed.
- If you are interested in opting your child out of State tests, you should consult with your child's principal. If, after consulting with the principal, you still want to opt your child out of the exams, the principal will respect your decision. The parent and the principal should maintain a written record of this conversation.

Students who do not participate will not receive a score.



Grades 3-8 NYS Assessments When will I find out how my child performed?

New York State usually releases test scores during the summer and the scores will be made available through your child's <u>NYC Schools Account</u>.



June Regents, Second Language Proficiency (grade 8) and World Language Comprehensive Exams (high school only)



Regents Exams & Second Language Proficiency

For students participating in accelerated courses, the Regents is the culminating assessment.

Schools should not administer the grade 8 state tests in the corresponding subject area to these students.

Grade 8 students may take the Second Language Proficiency for high school credit.
