

Specialized High Schools Admissions Test (SHSAT) Updates

Middle schools will administer the Specialized High Schools Admissions Test (SHSAT) to their current students in grade 8 on **November 8**.

Test Dates and Locations:

- Registered grade 8 students who attend a public DOE middle school will test at their current school during the school day on **November 8**.
- Registered grade 8 students who attend charter, private, parochial, or independent schools, or who are homeschooled will test at a central DOE location (under Test dates and locations) on **November 18 and 19.**
- All registered grade 9 students will test at a central DOE location (under Test dates and locations) on December 3 or 9.
- Student Registration: Students must register for the SHSAT by October 27.

2023 NYS Grades 3–8 ELA and Math Exam Results Embargo Lifted

The embargoed results for the 2023 New York State grades 3–8 ELA and math exams were released. The embargo has been lifted and schools may now share grade-level and school-wide results with their communities, as part of informational or professional-development sessions.

Prepare for 2024 NYS Grades 3–8 ELA, Math, and Science Exam Administration

The New York State (NYS) grades 3–8 English Language Arts (ELA) and math exams will be administered in April and May, respectively; the grade 5 and grade 8 ELA, math, and science exams will be administered via computer-based testing (CBT) in May. Schools may optionally participate in CBT for grades 3, 4, 6, and 7 in 2024, and testing modality in the CBT optional grades will be determined by the school principal.





