Becca Staley, Co-President of the Presidents' Council, spoke about the dates of the Quarterly Meetings with the CEC.

Presentation – Fair Student Funding: District 30 Superintendent Lisa Hidalgo and Brian Chan, Budget Director

The presentation reviewed the overall public school budget, the Fair Student Funding formula, and the new pages created to offer more transparency. Fair Student Funding is the largest funding stream. The total DOE budget is 39.4 Billion dollars; the District 30 budget is 514 million dollars, and 446 million dollars, 87%, is from Fair Student Funding.

- In-person and virtual interpretation services for scheduled family meetings available from the DOE's contracted vendor Geneva Worldwide.
- Free translation of general documents, such as flyers, handbooks, brochures, and newsletters, into the DOE's nine covered languages (Arabic, Bangla, Chinese, French, Haitian Creole, Korean, Russian, Spanish, and Urdu) are available. To make a request, complete the Office of Language Access's (OLA) Translation Request Form.
- Free translation of Individualized Education Programs (IEPs) into all languages. To make a request, complete the OLA's IEP Translation Request Form.
- Additional document translation support, including the translation of general documents into additional languages, expedited translations, and specialized documents, such as special education evaluations, is available from the DOE's contracted vendor Lingualinx.

Summer Rising Is Back for Students in Grades K-8

The NYC Public Schools (NYCPS) is looking forward to partnering with the Department of Youth and Community Development (DYCD) once again for Summer Rising 2024. Summer Rising connects elementary & middle school students to fun, culturally relevant, and hands-on experiences that strengthen their academic, social, and emotional skills. Summer Rising is free and open to any NYC student currently in kindergarten through grade 8.

Grades K-5

The Program will run from July 2 – August 16, 2024, Monday through Friday from 8:00 a.m. – 6:00 p.m.

Grades 6-8

The Program will run from July 2 – August 8, 2024, Monday through Thursday from 8:00 a.m. to 4:00 p.m.

Students will be provided with **free breakfast and lunch**. Programming will include academics led by NYCPS staff and enrichment activities held by the DYCD Community Based Organizations (CBOs).

The application will open in **early March**, and close in late March. This year, for the first time, families can apply for Summer Rising online using **MySchools**, the online directory and application system.

To apply, parents or guardians can log in or create a MySchools account at MySchools.nyc using their email address, their child's 9-digit student ID number and a MySchools account creation code, which they can get by contacting their child's school. If they have applied using MySchools before, their child will already be added to their account. For general support families can call 311.

Families can list as many programs as they would like on their application; it is recommended that families list as many programs as possible to increase the likelihood of being placed in a program of their choice.

This process is **not** first-come, first-served; all applications will be considered at the same time after the window ends. If families wish, they can make changes to their application at any point within the application window.

Offers will be released in mid-April. Parents or guardians should log back in to MySchools to view results.

CHAMPS Sports and Fitness Program: Spring Season Applications

As a follow-up to the CHAMPS program updates in October, schools with grades K–8 can now apply for the spring season (**April 8–June 14**) of the CHAMPS Sports and Fitness Program.

Eligible schools should apply online. Programs will be awarded proportionally across boroughs based on available funding. Schools with the most socially vulnerable students will be prioritized, including those with high chronic absentee rates and high numbers of students in temporary housing.

Meet Courtney, a dynamic Special Education teacher whose deep commitment to student success is reflected in how she is taking advantage of HMH Into Reading to provide all her students with access to grade-level work.
